### Preamble to inspectors' report

Preamble to inspector's report, this might include general background about the zoo (type of collection, size, etc) and any relevant information or comments from the pre-inspection audit.

Dublin Zoo was founded 190 years ago and is governed by the Council of the Zoological Society of Ireland. It is situated on a 28 hectare site in Phoenix Park near the centre of Dublin. The zoo has always faced some challenges due to its location, in particular the lack of dedicated car parking which is believed to impact on the visitor revenue potential, particularly during busy periods in the park.

The inspectors want to make it clear that although it may seem that a relatively large number of conditions have been issued during this and the previous inspection, this does not reflect poorly on Dublin Zoo. Dublin Zoo is a modern facility which, in our opinion, is well run and has the welfare of the animals it cares for at the heart of each decision made by the operators.

The zoo director, zoo curator & veterinary team have all joined the zoo during the past three years and are working hard to update historical issues with pre-existing exhibits and habitats as well as striving to implement new processes. The standards at Dublin zoo are very high, and it is clear from talking to various keepers and other staff that there is an an eagerness and significant support for the management & the improvements being made. The keepers were found to be experienced and knowledgeable and wholly dedicated to the animals they look after.

We would like to advise the operators that we are trialling a new inspection process beginning in 2022. We intend to move some aspects of the inspection onto a three year cycle, typically those areas that do not change significantly on an annual basis and have a longer term plan and objective. Examples of this include education policy and programs, research programs, conservation projects, preventative health programs, animal training programs etc.

This variation of the rigorous inspection process will afford inspectors more time to focus on those areas that require annual inspection, such as daily veterinary care, animal welfare and daily operations. It is also hoped that this will reduce the administrative burden on the zoo operators and provide clarity on the areas of their work which will be inspected each year.

The inspectors would like to thank the zoo director, curator, vet team and all the keepers for their hospitality and openness during the inspection. In addition, the provision of a completed PIA and associated documentation assisted with the efficiency of the inspection process on the day.

We would like to commend the veterinary team specifically for the hard work they are committing to the zoo, along with the proactive approach they are taking towards holistic veterinary care of all species.

In addition, the inspectors were particularly impressed with the very high standard of care provided in the reptile house (Zoorasic World).

It is also recognised that significant developments are underway and scheduled for completion during 2022, 2023 & 2024. These will lead to upgrades of existing enclosures and new housing & shelters in a number of exhibits and we look forward to seeing the improvements at the next inspection.

#### RECOMMENDATIONS

- 1. Whilst the installation of a number of lockable boxes across the zoo for storing dispensed veterinary medicines is to be commended, the inspectors would suggest that the temperature in these boxes is regularly monitored and recorded a data-logger may serve this purpose well.
- 2. It is recommended that a review is undertaken of any paint lines that are implemented to demarcate safe spaces in hazardous animal housing in order to ensure that they are present and clearly visible where they are required.
- 3. Although it is understood that the current lion house is to be re-purposed, the inspectors would suggest the installation of mirrors in the end dens in the meantime, and potentially also in future, in order to allow better visibility into all the corners of all dens.
- 4. It is understood that a full dietary review is scheduled to be undertaken in the near future, in conjunction with the veterinary team. The inspectors would advise that a specific assessment is made of the current practice of implementing fasting days for the carnivores.
