Preamble to inspectors' report

Dublin Zoo was founded almost 200 years ago and is operated as a charity governed by the Council of the Zoological Society of Ireland. It is situated on a 28 hectare site in Phoenix Park near the centre of Dublin and is one of the most visited tourist attractions in Ireland.

As the zoo counts down to its bicentennial in 2031, there is an ongoing push to meet the ambitious 10 year vision outlined in their Dublin Zoo 200 document published in 2021. This vision is based on five main objectives and the inspectors are impressed with the progress that has been made across all of these areas in the period since the vision was released. In particular, the newly renovated Society House which acts as the base for Dublin Zoo's role as an IUCN National Centre for Species Survival, for which an MOU has been signed with the IUCN.

In addition to dedication to conservation, the zoo continues to strive to continually improve animal habitats within the zoo, with a clear focus on animal welfare.

NB The inspection was carried out over two days, 27th and 28th May 2025. The first day focused mainly on inspecting the veterinary department, the stores and a tour of the site. The second day focused in the morning on the elephants specifically and then the education, conservation and research activities of the zoo.

The inspectors would like to thank all of the staff at Dublin Zoo for their hospitality and time during the inspection. The inspectors were pleased to see the progress that is being made to achieve the zoo's objectives.

It was noticeable that there is a very active and keen desire to constantly improve and refine the care that the zoo provides to its animals. It is to the zoo's credit that this effort involves all members of staff, whether involved directly or indirectly in animal care. Considerable effort is made to allow staff to feedback their experiences and for information to be shared with staff.

The zoo is to be commended with the appointment of a dedicated Behavioural and Welfare scientist. Welfare is an obvious priority for the collection and that staff are trained in what welfare means. A novel zoo Animal Welfare Master Plan is in development, focal welfare assessments are taking place. There is a holistic approach to husbandry, welfare and behaviour and a multi disciplinary effort to identify and solve challenging animal management situations.

As well as the care that the zoo offers its animals, it is also aware of the affect that the death of elderly, long term animals can have on staff. The zoo is to be commended for providing specialist external support to staff at these times.

There is an impressive and oversubscribed friends of the zoo team, numbering about 130 volunteers. A three day induction course is held and their beneficial presence was noted around the park.

The zoo has developed many Master Plans, not only for the strategic development of the zoo but also for other areas such as Sustainability and Conservation and that these plans are publicly available. The needs of disabled visitors are considered with various schemes. There is a Changing Place Toilet, the annual Dream Night event, some disabled interns in the shop, a link up with Deaf Village Ireland and also CHIME, a sign language initiative which is due to commence shortly.

Additional space

There are some single animals present in the zoo. The zoo is aware of these and is actively trying to bring in companions for these animals, e.g. another orangutan is currently undergoing pre-movement tests prior to moving to Dublin. The inspectors recognize that many reasons outside of the zoo's control can delay the arrival of new animals. However, it is important that the zoo continue to ethically review and welfare assess these solitary animals and make appropriate modifications to their care were necessary. The following recommendations are made: 1: That the floor in isolation room 2 is repainted and that the vivaria are placed on mobile boards to allow for easier cleaning. 2: The zoo could consider Quite Hours or similar out of hours programs for autistic visitors. **END RECOMMENDATIONS**
